If there is a conflict between JJ Cleaning Services website terms and conditions of use and these Terms, these Terms shall prevail.

Grant of Rights

You may use the Service for the purpose of making payments to JJ Cleaning Services via online credit or debit card transaction, provided that you do not:

In any way damage or disrupt the Service and/or the operation of the Service;

Use the Service for any unauthorised or unlawful purpose.

Payments may be made using the Service for invoices generated by Us, Gocardless, stripe our online payment systems.

You cannot use the Service for the transfer of money into any accounts apart from the JJ Cleaning Services accounts. You can't use the JJ Cleaning Services Payment system to send money to anyone no money should leave the United Kingdom that is connected with us. Failure to follow these regulations is a federal offense set by the (FCA) Financial Conduct Authority.

We reserve the right to suspend, amend or cancel the Service at any time either temporarily or permanently But all any outstanding debt will needed to be paid in full before we can terminate your account and cancel any direct debits you have with us. If you have no outstanding debt your account will be terminated on the same day.

Payment

Payments using the Service may be made only using only Visa or MasterCard credit cards.

We are not directly involved in the online payment but through a thirdparty service provider.

All payments are to be in one of the United Kingdom approved foreign currencies; – British Pound (GBP), Pound sterling (SL)(WS) and Euro (NIR).

We accept part payment of client accounts only where full payment of the account is made by the stipulated due date in the invoice. All other payments must be paid in full and by no later than the final date for payment set out in the invoice if this changes we will give you a written copy this change has happened, so you are not breaching this online Payment T&Cs document.

Upon completing a transaction using the Service, you will be presented with a confirmation screen verifying the transaction details you wish to process. It is your responsibility to verify that all transaction information and other details are correct. You can request another copy of the invoice or receipt an no additional charge to you.

We have no liability for transactions which are incorrect as a result of inaccurate data entry during the use of the Service or for loss of data or information caused by factors beyond Our control.

You will receive a confirmation email once the payment has been received by Our third-party service provider.

Once a payment has been made it cannot be cancelled. We do not accept any responsibility for refusal or reversal of payments, which shall be a matter between you and your credit card issuer.

<u>Fees</u>

Payments made by credit card attract a merchant service fee which is dependent on the amount being transacted and the currency.

International cardholders using the Service may incur their own bank's international service fees, in addition to the merchant service fee.

We may refund your payment or part of your payment in accordance with sub paragraph (REFUNDS) Where there has been a refund by Us, we will deduct the merchant service fee payable from the refunded amount due.

Refunds

The credit card used in connection with the Service is issued in your name.

The information supplied by you is true and correct in accordance with the (FCA Financial Conduct Authority regulations.

To the extent permitted by law, we do not accept liability for any damage, loss, costs (including legal costs), expenses, indirect losses or consequential damage of any kind which may be suffered or incurred by you from the use of the Service. Any credit card details stored for recurring payments are done so on the DPS system. No credit card information is stored by Us, and We are PCI compliant.
